Parent PLUS Loan requirements are as follows:

- You must be the parent/step-parent of the student whose information is reported on the FAFSA. (Guardians & grandparents cannot apply.)
- File the Free Application for Federal Student Aid (FAFSA) with the Department of Education
- Complete all sections of this pre-application and return it to the Office of Student Financial Aid (address/fax number below).
- Sign the electronic Parent PLUS Master Promissory Note (eMPN) at the Department of Education's website at <http://dlenote.ed.gov>. You must have your Department of Education Personal Identification Number (PIN) to sign the Parent PLUS eMPN. This is the same PIN that you use to sign your student's FAFSA. The signature process is complete once you can view the screen that indicates SUCCESS! Now *Print your MPN.*
