The U.S. Department of Education requires that we verify your selective service registration.
Men aged 18–25 are required to register with the Selective Service System (SSS).
We must have this completed form and documentation before we can continue processing your financial aid.

- I was born a female and am not required to register.**
- I am currently in the armed services on active duty.**
Note: This does not apply to members of the Reserve and National Guard who are not on active duty.
- I was born before 1960 and was not required to register.**

- ⇒ **To register or request a Status Information Letter, go to the Selective Service web-site at www.sss.gov and select "Registration Info."**
- I am a non-citizen who entered the U.S. after turning 26, OR**
- I entered the U.S. as a lawful non-immigrant on a valid visa and remained in the U.S. when I turned 26 or older.**
- **Attach** a copy of your birth date from a driver's license or state ID, birth certificate or passport, **AND**
 - **Attach** documentation of immigration entry date into the U.S.:
 - ◇ **For entry after age 26** - A date stamp on the I- 94 form; **OR** a dated passport immigration stamp
 - ◇ **For proof of status in U.S. until you turned age 26** - A letter from the [U.S. Citizenship and Immigration Services](http://www.uscis.gov) (USCIS) indicating your entry date; **OR** a student visa form (I-20) or other valid U.S. passport visa stamp. A Resident Alien Card (Green Card) is not sufficient proof of date of entry.
- I am a male U.S. citizen, permanent resident alien, refugee or political asylee age 26 or older, who did not register for selective service as required by law. Eligibility for aid will be determined by the financial aid office based on documentation submitted. Ignorance of the law is not excusable.**
- **Attach** a Status Information Letter from Selective Service - request a letter at www.sss.gov **-AND-**
 - **Attach an explanation** describing your failure to register for selective service, including any extenuating circumstances and whether you knowingly or willfully failed to register as required by law.

Be sure to include your name and student ID number on any documents you submit.
